DIAMONDHEAD WATER AND SEWER DISTRICT REGULAR MEETING MINUTES

The presence of a quorum was noted and the meeting was called to order at 4:01pm. The public was duly notified in compliance with the District's open meeting policy.

2. Approve Agenda.

Motion by Commissioner Griffith, second by Commissioner Taylor to approve the agenda. Motion carried unanimously.

- 4. Minutes.
 - 4.1. <u>Motion by Commissioner Ertel, second by Commissioner Beisecker to approve the minutes for the Regular Meeting held on December 16, 2021. Motion carried unanimously.</u> (Attachment A).
- 5. General Manager's Report.
 - 5.1. Update of Projects & Recent Events.
 - **5.1.A.** The District had one confirmed case of COVID-19 recently and that person has returned to work and doing well. Safety protocols remain in effect for all departments.
 - **5.1.B.** The main line horizontal directional drilling on Hilo Way for the Southeast Water Main Replacement Project has been completed. The contractor is moving to Lanai Street and Maui Circle to continue directional drilling in that area, with only three remaining drills. Approximately 1,100' of 6" pipe remains to be installed. The contractor has begun installing the direct bury pipe.
 - **5.1.C.** The preconstruction meeting for the Elevated Water Storage Tank Project was held January 13, 2022 between CB&I, Digital Engineering, and District Management.
 - **5.1.D.** Digital Engineering will be submitting pre-final plans for the Water System Improvement Project Phase I & II on January 20, 2022. Final details and specifications are being completed.
 - **5.1.E.** Engineers have finalized flow data retrieval from seven lift stations. The data is being input into the Sanitary Sewer System Hydraulic Model to perform simulations to adapt the model to accurately represent the data received.
 - **5.1.F.** Design drawings for the Sewer Improvements Phase I & II (Basins 13,16,17) Project are complete and a recommendation to authorize the engineer to advertise for bids is on the agenda.

- **5.1.G.** The District has installed 1 new water & sewer connection, 22 new sewer cleanouts, set 15 sewer cleanout covers & castings, replaced 4 sewer manhole castings in Basin 26 area, and have performed 5 water service repairs, and 2 sewer service backups since the last Board Meeting.
- **5.1.H.** Due to a pump failure at Well#1 and the emergency services required, the District hired a contractor which specializes in large commercial well pump repairs with heavy crane equipment to pull the pump from the well and assess the damages. Severe wear was observed, quotes were obtained, and service was procured to replace the pump and components as urgently as possible.
- **5.1.I.** The temporary pipe supports placed by the District on Kolo Court in an attempt to prevent sewer main damages from an eroding ditch bank collapse is holding steady.
